### Worksheet and Code Change Proposal Review:

Reviewed Minnesota Rules, chapter 1305, changes to chapters 7-10 of the 2021 and 2024 International Building Code, including worksheet items 390 – 515 that correspond to IBC sections 1010.2.12.1 – 1031.6.

#### Items 391 - 402 – Minnesota Rules, part 1305.1010, subpart 6a – Controlled Egress

The TAG discussed the current Minnesota modification and the corresponding 2024 IBC provisions. The TAG consensus is to accept the IBC model code language for items 1, 2 and 3 and repeal the Minnesota amendments for these items. The TAG consensus to retain the modifications in Minnesota Rules for items 5, 7, 8, 10. The TAG consensus is to repeal the Minnesota amendment for item 9 because it conflicts with items 1 and 2.

#### Item 427 – IBC 1014.3 – Lateral location

TAG discussed the new IBC section on handrail projection. This item was tabled for further discussion and a code change proposal may be submitted.

#### Item 438 – Minnesota Rules, part 1305.1015, subpart 3 – Window openings

TAG members tabled this item to review with Minnesota Statutes, section 326B.106, subdivision 7. This item will be discussed at a future meeting.

#### Items 463 and 471 – IBC 1023.5 and 1024.6 – Penetrations

The TAG discussed the IBC exception to these sections which Minnesota has deleted in its entirety. This item was tabled to be discussed at future meeting with a forthcoming code change proposal.

Items 495 - 504 – Minnesota Rules, part 1305.1030, subpart 1 – General

The TAG discussed the differences between the current Minnesota Rules and the model code language of the IBC. The discussion was tabled for the next meeting as the discussion was detailed and more time was needed.
