  - Follow-up on Structural code sections from the Structural TAG with their TAG consensus decisions. Report from Wendy Rannenberg, co-chair of the Structural TAG.

We had completed up to line item #11-9 of the 1311 TAG Worksheet page 23 – the end of Chapter 11 of the IEBC. Review will continue for IEBC Chapters 12, 13, 14, and 15.
