

7. Complaints

Alan Roebke addressed the board – see Attachment C.

- Roebke said he addressed the Board previously last year regarding work done by a non-licensed electrician completing wiring in his rental property. Building permits weren't filed and no electrical inspection was completed. He has numerous 3-prong outlets but there wasn't a ground fault breaker box. He has tried to get the City, Township and County to inspect this work. He also contacted Tony Thompson at the Department of Labor and Industry. Roebke described numerous issues and asked if the board could contact legislators regarding providing inspection protection to low income renters. He said he also
- Chair Hendricks said he doesn't have the capacity to require what should go in Bills brought to legislators. Electrical inspections are performed at the time of the installation or upgrade.
- Lebowski said the Minnesota Attorney General's Office Consumer Division deals with tenant's rights. This link was sent to you previously by Mr. Durenberger.
- Roebke said he did contact the Attorney General's Office and received correspondence but then that person was transferred, and he never heard back from anyone.
- Chair Hendricks said that Roebke is a constituent and can contact legislators as well as reaching out to the Attorney General's Office.
- Roebke asked that a recording of the board meeting be sent to him via email.

- Hunter clarified that Mr. Thompson is a senior investigator for the Enforcement Unit, not the Electrical Inspection Unit, at the Department of Labor and Industry.
- Chair Hendricks said there is currently an investigation into Mr. Roebke's concerns.







Mr. Roebke:

We understand the issues you've raised, and I suspect that the Alexandria area has been no different from most other communities in Minnesota for decades. However, that does not mean that the State has authority to conduct inspections of existing buildings and require that they be brought up to current code. There are other avenues for renters to pursue if they feel their landlord is not providing the type of living situation called for in their rental agreement. If you have not done so already, I suggest you visit the Attorney General's website for information on renters' rights: Table of Contents - Landlords & Tenants | The Office of Attorney General Keith Ellison (state.mn.us)

As for your request that we order certain individuals to stay off a particular property, we have no legal authority to do so. I suggest you contact the Alexandria Police Department with your concerns about the presence of unwanted visitors in the property you are renting.

Here are my notes from the meeting, is there anything you'd like to add Alan, or revise? The recording is not available yet – it takes a few hours to generate so these notes are based on what you sent in and discussion at the meeting:

Alan Roebke addressed the Board regarding upgrading electrical requirements for old rental houses and duplexes. Board members were previously sent a video link, https://youtu.be/9TN7UMDP1mg, of an overloaded 15-amp circuit with two old prong outlets that should be updated to commercial grade, three prong outlets for safety and convenience. Older rental houses and duplexes are required to upgrade their electrical breaker boxes to ground fault, arc fault breakers in their electrical panels. He discussed whether legal action could be taken against electrical contractors that fail to do so and whether the Board can require updates to electrical systems to simply and modernize for safety. Chair Hendricks said the Board understands these concerns; however, the local authority having jurisdiction is responsible for inspections and code requirements, not the Board. Roebke said he believes the Department of Labor and Industry should address these electrical issues and will contact Charlie Durenberger regarding enforcement actions.
